ITEM 1 INTRODUCTION	Synergy Capital of Colorado LLC ("Synergy Capital" or "Firm") is registered with the Securities and Exchange Commission (SEC) as an investment adviser. Brokerage and investment advisory services and fees differ, and it is essential for you to understand these differences. ITEM 2 RELATIONSHIPS & SERVICES	 WHAT INVESTMENT SERVICES AND ADVICE CAN YOU PROVIDE ME? Synergy Capital offers investment advisory and financial planning services to municipalities, corporations, high net-worth individuals, trusts, charitable organizations, and estates. Synergy Capital manages advisory accounts on a discretionary basis. In a discretionary account, you have granted written investment authority to your Financial Professional to execute purchase and sell orders in your advisory accounts without consulting with you first. You may limit our discretion, such as by imposing reasonable restrictions on investing in certain securities or groups of securities. Our Firm monitors your investment advisory accounts, and specific investments within your accounts, on an ongoing basis to align with you rinvestment goals. This service is included as part of the Firm's standard advisory services. If appropriate and suitable, our Firm may recommend utilizing the services of a sub-advisor in a "Separately Managed Account" (SMA) for the management of specific accounts. Upon the recommendation, we will review with the client initial due diligence on the SMA Managers we work with, and if the client agrees with the recommendation, the SMA's Manager will be engaged to handle security selection and trading within the parameters we establish with the client and the SMA Adviser. We impose a \$1,000,000 minimum account value to initiate our Firm's advisory and money management services, however, this may be waived as deemed appropriate by the Firm. Our Firm offers financial planning services as part of our investment management services, however, if requested, we offer standalone financial planning services. 	WHAT FEES WILL I PAY?
ITEM 3 FEES, COSTS, CONFLICTS, AND STANDARD OF CONDUCT	Synergy Capital of Colorado LLC charges a fee as compensation for providing Investment Management services. Fees are defined in the client Investment Advisory Agreement. Synergy Capital's annual fees are based upon a percentage of assets under management not to exceed 2.00%. Fees are billed quarterly, in advance, based on the market value of the account(s) on the last day of the prior quarter. For clients engaged in our investment management services, our financial planning services are included in advisory fees described above. For clients only engaging our Firm for financial planning services, financial planning is offered under a separate agreement and separate fee. Fees may vary based on the extent and complexity of your individual or family circumstances. Our fee will be agreed in advance of services being performed and negotiated with you. Financial planning fees are fixed and range from \$2,500 to \$10,000. For clients engaged with the Firm's sub advisory services, the client will pay a portion of the fee to Synergy Capital, and a portion of the fee will be paid to the sub advisor. The all-in fee of Synergy Capital and the Sub Advisor will not exceed 2.00%. Although Synergy Capital has established a maximum annual fee as stated above, we retain the discretion to negotiate alternative fees on a client-by-client basis. Our fees generally increase as client accounts grow, so we have an incentive to encourage our clients to increase the amount of assets in the accounts that are under our management. You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.
